Reports to: Director of Fiscal and Facility Operations

Purpose: Maintain accurate documentation of service and client records.

Responsibilities to include:

- 1. Complete data entry, analysis/reconciliation and record maintenance on the following systems;
  - a. SAMS (Senior Assistance Management System) software.
    - i. Keep up to date client records.
    - ii. Input monthly data from sites & Social Service Department to report to the Area Office on Aging of Northwestern Ohio (AOoA).
    - iii. Use data to support monitoring visits.
  - b. PASSPORT/MyCareOhio(Medicaid waiver program);
    - i. Handle daily calls from PASSPORT/MyCareOhio case managers regarding new & existing clients.
    - ii. Input monthly data from sites to prepare PASSPORT/MyCareOhio billing.
    - iii. Work with Director of Social Services on PASSPORT/MyCareOhio reimbursable billing, as appropriate
    - iv. Maintain records and ensure compliance with PASSPORT/MyCareOhio "conditions of participation" with required documentation/recordkeeping.
  - c. MSC (MySeniorCenter touch screen & software)
    - i. Monitor / verify client records, maintained in the WCCOA database (MySeniorCenter).
    - ii. Maintain, train and troubleshoot system as necessary.
    - iii. Use data to compile reports.
- 2. Provide support to the Executive Director, Director of Food Service, Manager of Human Resources and Site Managers in processing accurate documentation in each of the systems.
- 3. File and maintain documentation to support data entry.
- 4. Coordinate computer maintenance, including;
  - a. Set up and train computer log-in and e-mail for new staff.
  - b. Troubleshoot computer issues before initiating a service call to outside source.
- 5. Update and maintain WCCOA website.
- 6. Attend approved conferences and workshops for professional development.
- 7. Perform other duties as assigned.

## **Qualifications and Essential Skills:**

Education requirements: High School diploma required. Computer knowledge and proficiency required. Must demonstrate effective communication skills.

## **Minimum Requirements:**

Must have a proven record of working harmoniously with older adults as well as colleagues. Must be eligible for bonding and insurable under agency policy. Must possess a valid Ohio Driver's license with proof of auto insurance (state minimum). Must meet the requirements contained in Ohio Administrative Code (OAC) 173-3-06.6 (B)(3). Compliance shall be reviewed not less than annually. Must successfully complete Bureau of Criminal Investigation (BCI) records check, as defined in OAC 173-9-01.

## **Abilities Required:**

Must demonstrate fluency in English, both written and oral. Must be able to lift a minimum of 50 pounds consistently.
