- The **deadline** for applications is Friday, December 1, 2023 and the application must be completed entirely to determine eligibility.
- **One application per household** will be accepted for consideration annually. Only grandchildren aged birth to 17 years will be considered for holiday gifts. No gift cards will be distributed.
- Submissions may be returned to any of the eight senior centers of the Wood County Committee on Aging or mailed to:

NOTE: Holiday Outreach Project funds raised through the Senior Centers in Wood County will be used by WCCOA to purchase gifts for eligible children. All gifts will be purchased and wrapped and delivered to your home during business hours.

Selection Criteria:

1. Applicant must be 60 years old and over.
2. Applicant must demonstrate a financial hardship.
Committee will review application criteria based on the current Federal Poverty Guidelines in addition to extenuating circumstances.
3. Applicant must be a Wood County resident.
4. Applicant must be the guardian of the grandchild(ren) and reside in the same residence.
